More mine tours.
Business plan, end use and workforce post mine operation.
Business model, timeline on employment opportunities, pay ranges and impact.
Lithium market demands.
EV battery recycling opportunities.
Safety of hauling raw lithium from Kings Mountain to Richburg.
Assessments and plans for environmental impacts and emergency response in case there is a spill.
Dewatering and potential for downstream property erosion.
Communication of site activities (dewatering, etc.).

2.1.2. 2024 Most Commonly Asked Questions

Table 3 lists the questions most frequently asked by CAP members in 2024 (sourced from previous meeting summary reports), along with the Albemarle team's responses as recorded at the time. See below.

Table 3: Frequently Asked Questions from CAP Members in 2024

Questions from CAP Members	Responses from the Presenters
In 2022 Albemarle was awarded a DOE grant, will the community of Kings Mountain be affected by the reduction in expenditures, market, etc.?	Albemarle has a 5-year period to implement the project with a provision to extend the time period if necessary. Investments in Cleveland Community College and Kings Mountain are not anticipated to be affected.
What is the permitting timeline?	The timeline for the permitting process is determined by regulators, but federal and state permit approval is anticipated to take at least 2 years.
Will the recent news of lower lithium prices have an impact on the timeframe at Kings Mountain, or will the company be unable to predict until lithium prices rise?	The market could potentially impact Albemarle's timeline.
Will mined material be processed onsite?	Processing, crushing, flotation, and dense medium separation is expected to be done at the Kings Mountain site.
What are Albemarle's plans after rocks are blasted for lithium? Where will Albemarle haul the lithium and what is the plan for how the company will handle leftover mining materials, crushing, hauling, etc.?	Albemarle has a crushing circuit along with a processing station to extract lithium.
Who holds the money that may be necessary to ensure closure of the mine site?	Albemarle plans to put money into a bond so the company cannot touch it.
Are there requirements for contractors to hire subcontractors?	Albemarle is working with contractors to encourage hiring local companies.
What is the status of the Gateway Trail?	Albemarle is working with the City of Kings Mountain on the Master Parks and Recreation Plan. Albemarle anticipates having the master plan by summer/fall and will be working with the board to figure out what makes sense to weave into a bigger community plan.
What will you do with the watery mud at the bottom (of the mine pit) once it has been dewatered?	Albemarle is still working on the details. The mix of water and sediment will need to be transported offsite. The material is expected to be tested and then taken offsite. The timeframe includes 4 months to remove the material.
Will the R&D Technology Center stay or are you demolishing?	Currently, Albemarle intends to leave the Technology Center where it is located.
When will blasting occur?	Albemarle intends to meet federal standards for blasting that say blasting should occur Monday to Friday during normal daytime hours. No blasting is anticipated for evenings or weekends.

Questions from CAP Members	Responses from the Presenters
Will mined material be stored south of I-85 on or near the Wellman Property?	No material is expected to be stored on the south side of I-85.
How much horizontal blasting will occur?	Anywhere from 200 ft by 100 ft, to 500 ft by 200 ft.
How deep do you anticipate the mine pit will be when finished?	The pit is expected to be approximately 800 ft deep; it is approximately 300 ft deep now.
You have a deal with Martin Marietta, are you still looking for business-to-business contacts?	Albemarle is still looking for partnerships and recently started working with the State of North Carolina.
Are you going to be using electric trucks?	Albemarle is not there yet; however, Albemarle has a partnership with Caterpillar that is more traditional.
Where can we find permits after they are submitted?	Most permit information will be put on the permitting agency's websites; however, local governments typically do not include specific permit information on their websites.
	Albemarle is working on ways to display permit information on the Albemarle Kings Mountain website.

3. 2024 ACCOMPLISHMENTS

In 2024, the CAP was successful in sharing information, continuing a channel for two-way dialogue between the Albemarle team and CAP members and fostering meaningful engagement. As a result of feedback from the CAP, Albemarle was able to accomplish the following:

- Helping shape the rubric used to determine how the available \$150,000 for "Celebrating Kings Mountain" grant money was distributed.
- Identifying gaps in the Environmental and Social Impact Assessment (ESIA) Scoping Report and the Intangible Cultural Heritage section of the ESIA.
- Providing feedback on collateral materials used at the mine rollout meeting held in June so they were more relatable.

4. FOSTERING TWO-WAY DIALOGUE

At the conclusion of 2024, Kristi Moore, CAP facilitator, asked CAP members what they learned during CAP meetings and what resonated with them most. Below is a list of responses from CAP members.

What resonated most with CAP members:

- "Mining operations—it was all new knowledge for me. I didn't know the importance of lithium batteries and the connection to electric vehicles."
- "Learned who Albemarle is and what you do."
- "Water, water, everywhere—learned about dewatering. We got to tour the dewatering facility; it was so cool to see it and learn how it will work."
- "Stuff we can't see. Thousands of bore holes and wells; now we have 3D [3 dimensional] renderings, and it really gave me a better understanding of why you need this property and not that one. Learned about geology of the pit; it is helpful to understand that essentially the pit is impervious. You can't see below the surface, but Albemarle has done a lot of work."
- "The End Land Use process—so interesting to see what people would like to see happen after the pit closes."
- "When you talked about the stock drop and its drivers. Would like to go beyond that, how is it continuing?"
- "That Kings Mountain has one of the largest lithium deposits in the world."
