# 2.1.1. 2025 Most Commonly Asked Questions

Table 2 lists CAP members' most frequently asked questions from January to June 2025 (sourced from previous meeting summary reports), along with the Albemarle team's responses as recorded at the time. See below.

Questions from CAP Members	Responses from the Presenters	
What does project completion mean?	Project completion means that all commissioning is done, the mine has reached commercial production, and the project meets design metrics so that everything can be turned over to operations.	
What happens to properties that Albemarle has acquired after the demolition of the existing structures has been completed?	The land will be reclaimed; the ground will be leveled, and everything will be taken away.

Questions from CAP Members	Responses from the Presenters
Will all structures that are being demolished be burned or will explosives be used?	No explosives will be used; large equipment will be brought in for structures that are not being burned as part of training for nearby emergency response organizations. Gas will be cut off at each structure and checked for asbestos. It should take a day or day-and-a-half to remove each structure, then Albemarle will reclaim the property.
Will anything be done to the Macedonia Baptist Church on Parkgrace Road?	The church lease does not expire until December 2025. Stained glass windows and some of the brick work have started to be removed by officials/members of the church. We continue to work with them to make sure they have the time they need to relocate; this property is slated for demolition later in order of priority.  First quarter demo properties are those solely owned by Albemarle, nobody lives there, they are completely empty. These properties have been identified as possible safety hazards.
Did you say that turnover of the water in the mine pit usually happens every decade?	Albemarle has two recorded events of the water in the existing mine pit turning over, one in 2018 and one now (2024). It is believed to be a phenomenon that occurs about every 10 years.
If the water in the mine pit turns over, will it turn back; if so, when?	It is anticipated that if that happens it may be this summer; however, Albemarle does not want to wait until summer to try to mitigate the odor. As the lake continues to be drained, and lower levels are reached, higher levels of H <sub>2</sub> S concentration are possible.
As water levels in the mine pit decrease, will the smell continue to be prominent?	The bottom layer of water and sediment in the mine pit has already been identified as having a possible odor. Albemarle anticipates that the water in the mine pit may continue to smell as lower water levels are reached.
Are the H <sub>2</sub> S levels caused by the water in the mine pit turning over harmful?	Monitor readings indicate that everything is under 1 part per million, which is well within the safe zone.
Do you have an estimation for how much lithium being mined will be used for batteries and how much will be used for medicine?	There is no way of knowing that; lithium use will change based on need at the time.
Do any of the mine's permits require Albemarle to state how the land should look after the mine is closed?	State mine permits require an End Use Plan. Albemarle needs to provide the State with what it thinks the vision will be for the land after the mine closes. Albemarle is talking to the community and asking them what they would like to see done with the land after mining is complete.
Are you drilling to avoid buildings?	Albemarle is conducting condemnation drilling to make sure facilities are not being built on top of the resource. It is an expensive mistake.  The Interactive Map on the Albemarle website is planned to be used to indicate drilling locations.

Questions from CAP Members	Responses from the Presenters
Why is some of the drilling being conducted onsite called condemnation?	Areas of the site need to be identified and "condemned" as not having lithium resources and these areas can then be used for maintenance shops or other buildings.
Have there been any great finds from the pit dewatering as the water in the mine pit gets lower?	The bed of a dump truck has been found; it is on one of the benches. There have been pieces of a drill, and an old goat village was also found.
Where can we recycle lithium batteries?	There is a box at the (Kings Mountain) Project Center. Many hardware stores, such as Lowes or Home Depot, will take them back. Recycling lithium batteries is highly recommended.  We anticipate there may be a market in the future for taking back lithium batteries; nickel and cobalt are also valuable elements found in the batteries, making recycling a sensible practice.
Is the lithium-bearing hard-rock mined out of Kings Mountain going to China?	Originally, Albemarle proposed building a lithium conversion facility in South Carolina, but because of the market headwinds, that project is on pause. Albemarle wants to diversify their global conversion network. The lithium needs to be sent to where the customers are. Eighty-five percent is being used for anodes, and primarily those customers are in China. As the lithium supply chain further develops in the Western Hemisphere, Albemarle anticipates that there will be a need for conversion facilities domestically.
How will the lithium get transported?	Concentrate is expected to be put in bulk containers and then transported (by boat, train, etc.). No chemical conversion is done onsite; it is all physical.
It looks like you will not have permits until 2026, does that mean you will start blasting in 2027?	Once all permits are secured, Albemarle expects to make a final investment decision. If approved, then the company plans to begin construction. It will take over 24 months to prepare the building facilities and prepare the old mine.
